We are satisfied as to the matters to which we must have regard, as set out in s.3, s.4, and s.105 of the Act and we grant the applicant an On Licence.

**Off-licence**  
Sections 17 to 20, and 64  
Sale and Supply of Alcohol Act 2012



Pursuant to the Sale and Supply of Alcohol Act 2012, 1ZERO2 LIMITED is authorised to sell alcohol from (but not on) the premises situated at 86 Riverstone Drive, Upper Hutt and known as 1ZERO2, to any person for consumption off the premises.

### Endorsement

Section 40 of the Act applies to this licence; and the licensee is authorised to sell alcohol from (but not on) the premises and deliver it somewhere else.

### Conditions

This licence is subject to the following conditions:

- (a) Alcohol may be sold at any time on any day
- (b) Alcohol may be delivered on the following days and during the following hours:

**Monday to Sunday 6am till 11pm**

However, no alcohol is to be delivered on Good Friday, Easter Sunday, Christmas Day, or before 1.00pm on Anzac Day.

- (c) The Licensee must take reasonable steps to verify that the prospective buyer of any alcohol is not under the purchase age. For internet orders, the licensee takes such reasonable steps if the website has an age verification prompt:
  - Once when the prospective buyer first enters the internet site; and
  - Again immediately before the sale of alcohol is completed
- (d) The Licensee shall take all reasonable steps to ensure:
  - No sale, supply or delivery to minors
  - No delivery to intoxicated people
  - No leaving alcohol unattended at a place of delivery
- (d) The Licensee must ensure that there is printed on every receipt issued for alcohol sold remotely, the License holders name, Licence number, and the date on which the licence expires.
- (e) The whole of the premises is undesignated

### Display of licence

The licensee must display on the internet site in a prominent place: the licence holders name, licence number, expiry date and either a legible image of the licence or a clearly identifiable link to such an image.

### Duration

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force—

- (a) either—
  - i. until the close of the period for which it was last renewed; or
  - ii. if it has never been renewed, until the close of the period of 12 months after the day it was issued; but
- (b) if an application for the renewal of the licence is duly made before the licence would otherwise expire, either—
  - i. until the close of the period of three years after the period for which it was last renewed; or
  - ii. if it has been renewed, until the close of the period of four years after the day it was issued.
